-- Ronald Smith, independent corporate director, former senior vice president and chief financial officer, Emera, Yarmouth

The standing committee on human resources approved the appointments today and they will be finalized shortly.

"Develop Nova Scotia has a critical role to play in the growth of our communities and economy and these Nova Scotians have the backgrounds and skills to help lead the Crown corporation's success," said Mr. MacLellan. As vice president of WM Fares Group, a well-established real estate and development company in Nova Scotia, Mr. Fares leads the operations at WM Fares Group including finance, construction, property management, business development, and marketing. He has served on various boards and committees including Family SOS, The Lebanese Chamber of Commerce, and the Centre for Family Business and Regional Prosperity at Dalhousie.

Develop Nova Scotia is responsible for leading sustainable development of high potential property and infrastructure across Nova Scotia to attract people and investment. Legislation to formally create Develop Nova Scotia as a new Crown corporation took place in the fall of 2018.
